Hong Kong Institute of CPAs Workshop on IFRS/ HKFRS 17 Insurance **Contracts**

On 4 January, the HKICPA issued HKFRS 17, a word-for-word adoption of IFRS 17 issued by the International Accounting Standards Board. HKFRS 17 will replace IFRS/ HKFRS 4 Insurance Contracts on 1 January 2021. Insurers reporting under IFRS/ HKFRS 17 now have three years to prepare themselves for the implementation of a standard that will affect accounting processes, actuarial valuations and IT infrastructure. Implementation may be costly and could take some insurers significant time and effort over the next three years.

This series of workshops will discuss the new requirements of IFRS/ HKFRS 17 you need to understand and be familiar with. They aim at providing an interactive learning experience for you to learn key concepts and how to apply the standard through a range of activities and exercises.
