ABOUT THE SEMINAR

On 23 February, HKEX <u>published</u> a consultation paper seeking public comments on the proposals to expand Hong Kong's listing regime to facilitate listings of companies from emerging and innovative sectors. The deadline for response is **23 March 2018**.

The paper includes draft new chapters in the Main Board Listing Rules to:

- (a) permit listings of biotech companies that do not meet any of the financial eligibility tests of the Main Board:
- (b) permit listings of companies with weighted voting right structures; and
- (c) establish a new concessionary secondary listing route.

At this seminar, Mr. Michael Chan, Senior Vice President of HKEX will provide an overview about the proposed new listing regime and answer questions from participants.
