- [Data Studio](#) – a both physical and virtual test-bed for data co-creations in a secured environment. It offers data application programming interface from industry partners for proof-of-concept development, and catalyzing data sharing and technology commercialization in Hong Kong.
- [Robotics Garage](#) – a co-working "makerspace" providing various tools, fabrication machinery and supportive staff to help robotics and electronics innovators turn their ideas into commercial reality.
- [Green Trail](#) – a "living laboratory" where the buildings are designed on sustainability principles and make use of three key design principles of reduction, efficiency and generation, to encourage smarter use of resources and a greener lifestyle at workplace.
