## About the topic

Blockchain technology has provided the foundation for the creation and development of digital currencies. Cryptocurrencies, like Bitcoin, are digital assets that work as a medium of exchange that use cryptography to secure their transactions. While these currencies provide alternative channel for people to settle their transactions, their safety and integrity have been questioned. Also, as there are no comprehensive regulations on cryptocurrencies, they are popular on the dark web, which enables criminals to conduct illegal transactions, including the sale of narcotics and money laundering activities.

In this seminar, the speaker will cover an overview of evolution of blockchain technology and cryptocurrencies, additionally, to discuss cryptocurrencies and their relationship to legal vs. illicit activities.
