



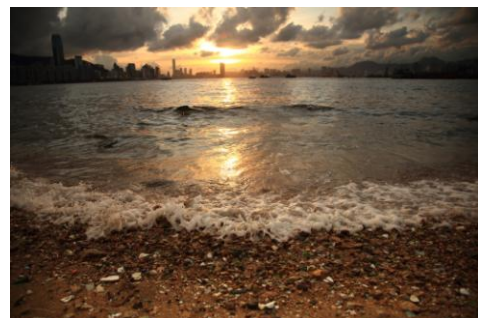

2. This event is subject to cancellation should the minimum number is not reached.
3. The Institute has the discretion to accept late enrolments after the closing deadline as it sees fit.
4. Unless the activity is cancelled due to unforeseen circumstances, low enrollment or bad weather, no withdrawal will be entertained after the enrollment has been processed.
