
- Theme:** 寶蓮寺大佛日落

- Venue:** Po Lin Monastery, Lantau Island (大嶼山寶蓮寺)
- Capacity:** Min. 28 persons (max. 45)
- Transportation Fee:** Approximately \$100/head for a round trip coach service between Tung Chung MTR Station and Po Lin Monastery (exact amount to be confirmed after successful registration).

- Remarks:**
1. Fee is made payable directly to the session leader, Ms. Irene Chiu.
  2. The session will be cancelled if the weather is not suitable for taking sunset photos. No reschedule arrangement will be made. The fee will be refunded, except the permit fee of \$500 applied for the coach diving on Lantau Island which will be equally shared among the participants.
  3. Participants should bring their own digital single-lens reflex camera (DSLR), telephoto and/or wide lens, filters (optional), shutter cord and tripod.
  4. Cantonese is the medium of the activity.
  5. Meals are not included. Participants should bring their own refreshment as needed.
  6. For easy communication and logistic arrangements, the session leader will create a WhatsApp group for successful enrollees.

4. Unless the activity is cancelled due to unforeseen circumstances, low enrollment or bad weather, no withdrawal will be entertained after the enrollment has been processed.
