Best Corporate Governance Awards series: Awardees share their views and experience on the good sustainability practices Programme Code: SCPD18091002

About the topic

Following the decision of Hong Kong Exchanges and Clearing Limited (HKEX) to strengthen the Environmental, Social and Governance Reporting Guide, increasing listed companies have published their individual sustainability reports. A recent analysis of ESG Practice Disclosure indicates that listed companies could make better disclosures.

As ESG reporting is still a relatively new area for Hong Kong, listed companies and public organizations could benefit from additional guidance and pointers on preparing a credible sustainability report. How do the top performers prepare their sustainability reports? Perhaps the best way for companies to take their sustainability practices to the next level is to learn by example.

In this seminar, speakers from the Airport Authority Hong Kong and CLP Holdings Limited, two repeat winners in our Sustainability Awards, will share their experience and best practices with us on a range of issues, such as SSR governance, stakeholder inclusiveness, materiality and completeness, the applicability of KPIs, and some emerging trends in SSR reporting.

She is leading the Group's Sustainability Report and investor surveys, and facilitating cross-team collaboration to drive sustainability performance.

She has more than ten years' experience in the area, working with multi-national utility companies. Her past works include initiating a strategic review of the future trends that could shape the company's long-term development strategy; devising a robust methodology to determine materiality for reporting and prioritising resource allocation; and pioneering a story-telling approach to reporting that helped expand stakeholder engagement opportunities.

Kit is a delegate in the WBCSD Leadership Programme 2018. She holds BSc and MPhil degrees in Molecular Genetics from the University of Hong Kong. She was a Chevening scholar at the London School of Economics and Political Science, where she received an MSc degree in Development Studies.

Mike Kilburn is the Assistant General Manager, Sustainability for Airport Authority Hong Kong (AAHK). He is responsible for developing and implementing AAHK's "greenest airport" pledge, through the "airport-wide" carbon and food waste management programmes. He is also evolving a wider sustainability strategy through the progressive development of AAHK's sustainability reporting process.

Mr. Kilburn is Vice-Chair of the ACI World Environment Standing Committee and immediate past Chair of the ACI Asia Pacific Regional Environment Committee.

Prior to joining AAHK in 2012 he worked in environmental and public policy NGOs in Hong Kong, where he developed policy-level solutions to the city's challenges around air quality management, biodiversity and land use planning.
