

Introduction and Experience Sharing on HKEx ESG Reporting

The ESG (environmental, social and governance) reporting requirements under the listing rules issued by the Hong Kong Exchanges and Clearing (HKEx), applicable to all Hong Kong listed issuers, were upgraded for accounting period beginning 1 January 2016. Every listed issuer is required to publish an ESG report, containing general disclosures on policies and compliance matters for respective aspects and environmental key performance indicators under the "comply or explain" principle. Listed issuers are facing a growing demand for disclosing non-financial information to their key stakeholders under the current reporting requirements and market expectation.

This seminar will enhance participants' understanding of the current ESG reporting requirements and gain insights of hands-on experience from ESG reporting practitioners and professionals. Topics include:

- Overview of current ESG reporting requirements
- Experience sharing on preparing ESG report, including key challenges and practical issues
- How to improve ESG reporting and disclosures
