

# The 15th Recreation and Sports Club for Hong Kong Professional Bodies Golf Tournament 2019

The 15th RSCP Golf Tournament will be held on **Wednesday**, **13 March 2019** at The Clearwater Bay Golf & Country Club Hong Kong. Other participating professions include architects, dentists, doctors, solicitors and surveyors.

The Institute is recruiting 20 members to form its representative team. Members, whose golf handicap **maximum is 28 (for men and ladies)**, are welcome to put forward their names for consideration. In the event that there are more than 20 members expressing their interest, an internal selection will be held based on members' handicap and past competition records, among other things.

To enable the selected teammates to meet up and get to know each other before the tournament, a pre-tournament lunch is tentatively scheduled on **Tuesday**, **5 March** at the Institute, 37/F Wu Chung House, 213 Queen's Road East.

Tees: White tees for Men. Red tees for Ladies.

Max. capacity: 20

Format: Individual Stableford off New New Peoria Handicap (NNP)

Prize: - The perpetual trophy will be awarded to the Champion team which can keep it for one year until the next tournament is held.

- A medal will be awarded to each contestant of the Champion, 1st and 2nd Runner-up

- A trophy will be awarded to the awardee from each team who gets the Best Gross Score.
- A trophy will be awarded to the awardee from each team who gets the Best Net Score unless the person has the Best Gross Score.
- A trophy for each winner who has won the Nearest to Pin.
- A trophy for each winner who has won the Longest Drive.
- Only players who stay for the dinner are eligible to participate in the lucky draw.
- Each Player is entitled to win one 1 Nearest to the Pin Prize and 1 Longest Drive Prize only.

  Recreation Committee and its decisions are deemed to be final.
- This is a member only event. Non-members including QP students are not eligible to join.
- 3) Full payment by cheque must be made before your enrolment will be processed. Application by fax will ONLY be accepted when payment is made by credit card. Cash payment and telephone reservation will <u>not</u> be accepted.
- 4) The closing date for enrolment is <u>15 February 2019</u>. However, the Institute has the discretion to accept late applications as it sees fit.

- 6) Unless the tournament is cancelled due to unforeseen circumstances or low enrolment, no refund for withdrawal will be entertained after the enrolment has been processed.
- 7) Bad weather arrangement: The tournament will be cancelled if typhoon signal no. 8 or above / Black rainstorm warning is hoisted 2 hours prior to the commencement of the tournament. Your enrolment fee will be refunded in full in the event of cancellation due to bad weather.
- 8) The Institute reserves the right to change the venue and date of the tournament due to unforeseen circumstances.
