Mr. Ma is a certified badminton coach and a former Hong Kong China badminton team member. He ranked 14th in the 2001 Badminton World Federation in the men's doubles event.

- **Selection** 1. Members will undergo a selection assessment conducted by the coach.
 - Two players will be arranged to play drills against each other. Both players are required to demonstrate attack / defend, backhand / forehand, drop shot / high clear, serve / receive, etc.
 - 3. The assessment is based on player's correctness of grip holding, form of playing, speed, power, serve the shuttlecock and accuracy, etc.
 - 4. The selection results will be announced by email.
