The course comprised of theory and sailing trip is suitable for beginners with little or no sailing experience. Seasoned sailors are welcome to join for skills de-rusting.

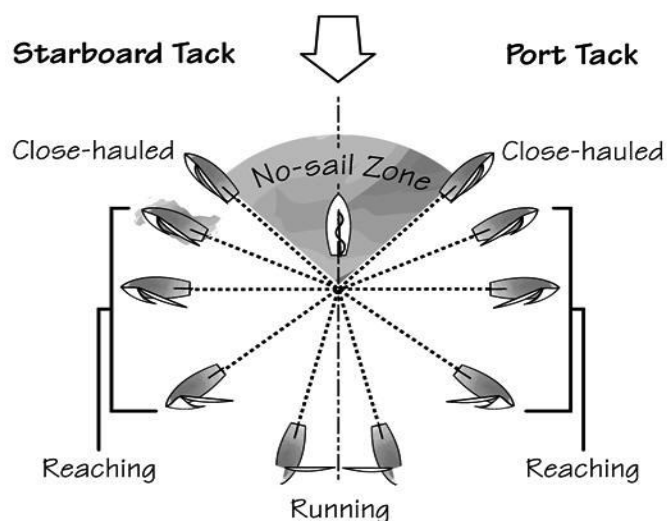
