


New competition format

1. Three events, including Men's Doubles, Women's Doubles and Mixed Doubles will be played.
2. The competition will adopt the double-elimination format for all events as illustrated below.
3. Players who won a match will proceed as usual in knock-out format in Group A, while players who lost will move on to Group B and have an additional chance to compete with other players. Players who lost two matches will be eliminated.
4. The new format ensures all players can compete in at least two matches, while majority will participate in three or more.
5. "Best of 3 games in 21 points" will be adopted for all matches except the final if the remaining time is 15 minutes or less. Championship will be decided by two games with 31 points instead in such case.
6. Player list, final rules and format will be distributed to all players after the open draw.

Terms for Enrolment in Sports IG Activities:

4. Successful registrants will receive confirmation by email or by telephone, whereas unsuccessful registrants will receive full refund.

6. The Institute has the discretion to accept late enrolments after the closing deadline as it sees fit.

8. Bad weather arrangement: The activity will be cancelled if typhoon signal no. 8 or above / Black Rainstorm Warning is hoisted 2 hours prior to the commencement of the course.
