

## Developments in Mainland/ Cross-border Bankruptcy and Insolvency from a judicial perspective: Judge Ci Yunxi (慈云西法官) and Judge Wang Fang (王芳法官) share their views

### About the topic

On 1 April 2019, Shenzhen Bankruptcy Court issued a new Guideline for Mainland Reorganisation / Corporate Rescue (深圳市中级人民法院审理企业重整案件的工作指引)("Guideline").

The Restructuring and Insolvency Faculty (RIF) is pleased to welcome three Mainland judges as our guests, two whom will be presenters at the coming RIF seminar.
