<導師簡介> 鄭凱剛 Caxton Kwong – CK Event and Production 及 C Studio 創辦人、音樂導師、職業結他手、樂隊 Crosstalk 結他手。活躍於香港流行樂壇十多年，擅長流行、搖滾和藍調曲風。除負責樂隊創作及擔任樂手演出外，過往更於廣州及香港大會堂，獲邀演出二胡演奏家李軍先生之新二胡唱遊流行夜；另外曾於生力 Wild Day Out Grand Show 演出，同台表演歌手包括黃貫中、恭碩良、蔡健雅、周國賢等。近年更積極參與音樂教育及編曲等工作，當中有伊利沙伯體育館「樂善好聲演唱會」為無伴奏組合「C Ensemble」四聲部編寫；2016 年為香港會計師公會代表作合唱和音編寫及指導，學生 Jacqueline Hsui 及 Ruth Leung 參加香港專業團體康體會歌唱比賽奪得「合唱組－季軍」及「全場最受觀眾歡迎組別」獎項。

3. Full payment must be made before your enrolment will be processed. No telephone reservation will be accepted.
4. The closing date for enrolment is **17 July 2019**. However, the Institute has the discretion to accept late enrolments after the closing deadline as it sees fit.
5. Successful registrants will receive confirmation by email or by telephone, whereas unsuccessful registrants will receive full refund.
