Remarks:

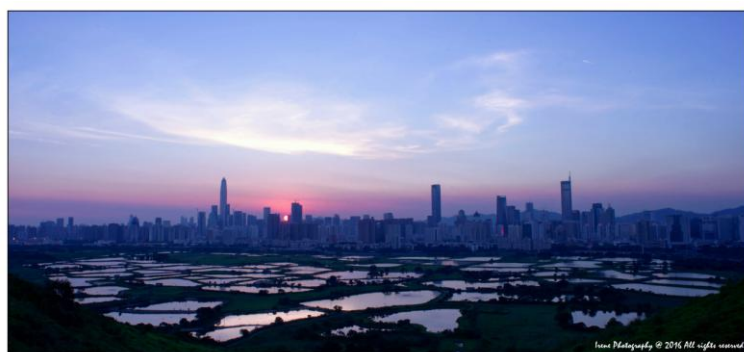
1. Fee shall be made payable directly to the session leader, Ms. Irene Chiu upon confirmation of your enrolment.
