Priority will be given according to the order of young members (i.e. aged 40 or below), members and guests in the case of over subscription. Non-members' applications will only be processed together with a member's enrolment, and their applications will be considered separately after the closing date for enrolment subject to availability.
2. All participants of the Institute must agree with the "Declaration, Assumption of Risks and Disclaimer of Liability" when they enrol. Participants are required to sign a consent letter issued by Impact Force C.Q.B. before the start of the game on the event day.
3. Full payment must be made before your enrolment will be processed. No telephone reservation will be accepted.
4. Application by fax will ONLY be accepted when payment is made by credit card. Cash is strictly not accepted.
5. Confirmation of enrolment will be sent to you via email before 16 August 2019. You can check your enrolment status at "MyCPA" at www.hkicpa.org.hk. Unsuccessful enrolment will be notified with full refund.
6. In normal circumstance, the admission fee is non-refundable or non-transferrable upon receipt of payment by HKICPA. Should the event be cancelled or postponed due to unforeseen circumstance, refund will be made according to your payment method.
