

# FOOTBALL Interest Group



The **Football Interest Group (FIG)** has organized two football leagues for members with different interest. Members who want to play for fun can enroll in Team A while Team B is suitable for those who want more challenges. Interested members can enrol in **either team** and competitions will be held between October 2019 and August 2020.

## Details

<b>Team</b>	Team A – Fun and leisure (9-a-side match); or Team B – Competitive and challenging (11-side match)
<b>Date</b>	October 2019 to August 2020 Matches will be arranged in the evenings of Monday to Friday
<b>Enrolment fee</b>	\$530 (Team A) \$600 (Team B)
<b>Team uniform</b>	\$310 per set (The same uniform as in 2018/19 will be used. New team members and those who want a new set of uniform should raise your request online during registration.)
<b>Capacity</b>	Min. 30 for each team
<b>Remarks</b>	<ul style="list-style-type: none"><li>- Owing to LCSD booking policy, the league organizer will announce match information within 9 days prior to the race day.</li><li>- The FIG convenor will create a WhatsApp group to share match information with team members. Please provide your mobile number for this purpose.</li><li>- Team members are required to confirm their availability through the league's WhatsApp group prior to each match. All team members are expected to show their utmost team spirit by commitment.</li><li>- The FIG Convenor, or a person appointed by the convenor in his absence, will assume the duty of the team captain and in charge of squad rotation from a tactical viewpoint during each match. Members should abide by the team captain's decision.</li></ul>
