- 1. Priority for enrolment will first be offered to TsIG members and then to non-TsIG HKICPA members in the case of over subscription.
- 2. This event is subject to cancellation should the minimum number is not reached.
- 3. Full payment must be made upon confirmation of your enrolment. No telephone reservation will be accepted.
- 4. The coach has the discretion to accept late enrolments after the closing deadline as it sees fit.
- 5. Unless the activity is cancelled due to unforeseen circumstances, low enrolment or bad weather, no refund for withdrawal will be entertained after the enrolment has been processed.
