- 1. Priority for enrollment will first be offered to DIG members and then to non-DIG HKICPA members in the case of over subscription.
- 2. This event is subject to cancellation should the minimum number is not reached.
- 3. The convenor has the discretion to accept late enrolments after the closing deadline as it sees fit.
- 4. Unless the activity is cancelled due to unforeseen circumstances, low enrollment or bad weather, no refund for withdrawal will be entertained after the enrollment has been processed.
- 5. Bad weather arrangement: The activity will be cancelled if typhoon signal no. 8 or above is hoisted at or after 2:30 pm on the date of the activity.
