### Notes to participants

- **Audio system:** Participants must **bring their own earphones** for the audio portion of the tour. Normal mobile phone earphones will be sufficient.
- **Dress code:** **Smart casual or office attire** is required. Shorts, T-Shirt, miniskirts, low cut, flip flops, sandals and slippers are not accepted. Those who breach this term will be asked to leave the tour immediately.
- **Transportation:** Participants are required to make their **own transportation arrangement** to and from Cathay Pacific City. Limited hourly rate parking is available on a first-come-first-served basis; however this fills quickly in the morning.
- Participants should take care of their own safety and bear all risks of injuries from accidents during the tour.
- Participants are required to stay in the group at all times during the tour due to security and safety reasons.
- Please do not take photos of any staff in general, the flight crews or instructors when training is in progress.
- Participants should not touch any training equipment.
- As some facilities are used for training purpose, participants are prohibited from taking photos and videos while training is ongoing. Those who breach this term will be asked to leave the tour immediately.
- Participants are required to follow the instructions of the Cathay Pacific representative and maintain order appropriately during the tour. Participants who fail to follow the reasonable instructions of the Cathay Pacific representative will be asked to leave the tour immediately.
- Participants are required to pay Cathay Pacific Airways all expenses incurred from legal proceedings, compensation claims and/or other payments resulting from any damages or injuries incurred during the tour.
- Cathay Pacific reserves the right to record the tour via video or photos, which may be used for TV broadcast or published in the print media.

- The Cathay Pacific (CX) requires participants to provide their names (English) shown on the Hong Kong Identity card ("HKID card") to apply for the permits. If the name does not match with their HKID card, participants will not be allowed to enter into the visiting places. On the event date, CX will check participants' HKID card before issuing the temporary visitor pass.**
- Enrolment for the activity is accepted on a first-come-first served basis. Priority will be given to young members (i.e. aged 40 or below) who are first-time participants to the similar visit in the case of over subscription.
- Full payment must be made before your enrolment will be processed. No telephone reservation will be accepted.
- The main course selection cannot be changed after the enrolment has been confirmed.
- Application by fax will **ONLY** be accepted when payment is made by credit card. Cash is strictly not accepted.
- Confirmation of enrolment will be sent to you via email before 27 November. You can check your enrolment status at "MyCPA" at [www.hkicpa.org.hk](http://www.hkicpa.org.hk). Unsuccessful enrolment will be notified with full refund.
- In normal circumstance, the admission fee is non-refundable or non-transferrable upon receipt of payment by HKICPA. Should the event be postponed due to bad weather, the event will be re-scheduled to another date.
- If a participant is no show at the event, he/she may be given a lower priority for joining future events organized by the Young Members Committee.
- Bad weather arrangement: The activity will be cancelled if the **typhoon signal no. 3 or above, or red/black rainstorm warning** is hoisted, as announced by the Hong Kong Observatory, at or before **8:00 am** on the date of visit.
