The tournament is divided into three categories:

- Men's Singles
- Men's Doubles
- Ladies' Singles

Basic rules:

- 1. Each preliminary match consists of 5 games with deuce sudden death (receiver's choice). The first to win 5 games will be the winner of the match.
- 2. The final match will be a 6 game set with deuce sudden death (receiver's choice). A tennis competitor can only close out the match when leading by two or more games. If the game score is tied at 6 all, the match will require a tiebreaker. In this case, the first player to receive 7 points, with a two point advantage, will win the match.
- 3. If the final match cannot be finished 15 minutes before the end of the tournament (i.e. 5:45 pm), one final game will be played. The Champion will be the player who has won the greater number of games in the set.
- 4. All players must arrive at the tennis court and check-in 15 minutes before the tournament / match starts (i.e. 12:45 pm). If any player is no show or late for 2 minutes after the match started, he/she will be determined as walkover and will be disqualified.
- 5. 3 new balls will be provided for each match.
- 6. A 3 minutes warm-up is allowed before each match.
- 7. Players must be full members of HKICPA. Students are not eligible to join the tournament.
- 8. Any argument or unsettled dispute will be judged by the umpires / coaches on behalf of HKICPA.

The Institute reserves the right to change the format, schedule and rules of the match as and when required without prior notice.

Terms for Enrolment in Sports IG Activities

Any enrolment in the activity is based on the participant's assessment that s/he is fit to participate and the assumption of all the risks and hazards inherent in the said activity. The participant agrees not to hold HKICPA or the convenor of the interest group liable for any loss or damage that the participant may suffer as a result of the participation.

The participant further agrees to follow the instructions from trainers (if any) and observe the <u>Event Participation</u> <u>Guidance</u>. Any failure to follow such instructions will result in the participant's exclusion from the activity. The convenor of the interest group or trainer (if any) may determine, in the interests of safety or other considerations, whether an activity shall continue or whether a particular participant is allowed to continue to participate.

Notes:

- 1. Priority for enrolment will first be offered to TsIG members and then to non-TsIG HKICPA members in the case of over subscription.
- 2. This event is subject to cancellation should the minimum number is not reached.
- 3. Full payment must be made before your enrolment will be processed. No telephone reservation will be accepted.
- 4. The closing date for enrolment is <u>15 October 2019</u>. However, the Institute has the discretion to accept late enrolments as it sees fit.
- 5. Registration will ONLY be processed via online. Cash is strictly NOT accepted.
- 6. Successful registrants will receive confirmation by email, whereas unsuccessful registrants will receive full refund.

- 8. Unless the activity is cancelled due to unforeseen circumstances, low enrolment or bad weather, no refund for withdrawal will be entertained after the enrolment has been processed.
- 9. Bad weather arrangement: The activity will be cancelled if typhoon signal no. 8 or above / Black Rainstorm Warning is hoisted 2 hours prior to the commencement of the matches. The match will be re-scheduled.
- 10. The Institute reserves the right to change the venue and date of the event due to unforeseen circumstances.
