About the topic

The Institute introduced Sustainability and Social Responsibility (SSR) Awards as part of the Best Corporate Governance Awards (BCGA) in 2011, given the increasing importance of sustainability considerations to listed companies and public sector organisations, investors and the wider community. This focus has also been reflected in the progressive development of the Environmental Social and Governance (ESG) Reporting Guide under the listing rules, including the recent requirements announced on 18 December 2019. The requirements will apply to financial years commencing on or after 1 July 2020, representing a paradigm shift from "reporting" to "management" with an emphasis on the board's role in the governance structure for ESG matters.
