Look's experience includes advising on (i) CEFC Shanghai International Group's cross-border insolvency assistance in Hong Kong, the first ever instance of Hong Kong/ Mainland cross-border insolvency cooperation; (ii) implementation of the scheme of arrangement of Asia Television; and (ii) various Lehman Brothers litigations, including the waterfall applications determining the priority of rankings for surplus assets etc..
