He is a Notary Public and a China-Appointed Attesting Officer, serving in these capacities for over 20 years.

Mr Siu advises on all aspects of legal matters including general civil and commercial work. He has been handling a broad variety of high profile cases covering a wide area. He has extensive experience in real estate related transactions and disputes.

Mr Siu is a Justice of the Peace and has been awarded the Bronze Bauhinia Star by the HKSAR Government. He has been appointed by the Government to provide pro bono services to various administrative boards and quasi-judicial bodies. He served as Chairman of the Housing Appeal Panel from 2007 to 2013, Chairman of the Buildings Appeal Tribunal from 2007 to 2016 and Deputy Chairman of the HKSAR Passports Appeal Board from 2013 to 2019. Apart from serving the Estate Agents Authority, he is at present the Chairman of the Environmental Impact Assessment Appeal Board.
