## Speakers



**Prof. Witman HUNG, JP**

Witman is currently the Hong Kong Deputy to 13th National People's Congress (NPC) and Principal Liaison Officer for Hong Kong, Shenzhen Qianhai Authority. A seasoned ICT professional and angel investor, Witman has worked in the industry for more than 30 years. He is the Executive Chairman of Chinese Big Data Society and Vice President and Secretary General of Hong Kong-ASEAN Economic Cooperation Foundation. He is also an Independent Non-executive Director of VSTECS Holdings Limited (0865.HK), Sino Hotels (Holdings) Limited (1221.HK), Sprocomm Intel (1401.HK) and LH Group Limited (1978.HK).

In 2008, Witman was selected as one of the Ten Outstanding Young Persons of Hong Kong. In 2016, he was given the Asia Social Innovation Leadership Award by CMO Asia. Witman is currently an Adjunct Professor of Jinan University and Hainan University, and is an Honorary Professor of Guangxi Normal University.



**Peter Kung**

Peter Kung is a National Committee Member of the 13th Chinese People's Political Consultative Conference. He is the Chairman of Supreme Genius Consulting Company Limited. He was Vice Chairman of KPMG China. He is also a Past President of the Taxation Institute of Hong Kong. He is a fellow member of the HKICPA, and Adjunct Professor of the Chinese University of Hong Kong and Beijing Normal University.

He has over 30 years of professional experience. He started his professional career in the United Kingdom and returned to Hong Kong in 1992. Since then, he has specialised in China tax. He is one of the very few tax practitioners in Hong Kong who is qualified to practise tax in the mainland. He holds regular meetings with the governments in the mainland and Hong Kong to exchange ideas on tax and foreign exchange policies that affect the two jurisdictions.



**Sing Chan**

One of the first Hong Kong young entrepreneurs setting foot in Qianhai, Sing Chan is the co-founder of SilverGreen Innovation Ltd., and CEO of Ekstech. He received the first round of financing of RMB50 million within a year after the set-up of Ekstech which was then fully acquired in 2017. Recently, he has established start-up incubators in four districts of Shenzhen for Hong Kong youth, serving over 250 project teams.
