Participants need to finish the event by foot without aiding tools, such as using of roller, bicycle, or any kind of vehicles.

Participants should finish the course in one go. Elapsed time will be counted instead of moving time. However, given that distance and display from different brandings of GPS equipment may vary, organizer will handle the results with flexibility. Participants should bring along sufficient food and drinks during the event. Provision of supplies such as food and water from supporter is allowed but not other kinds of assistance.

Organizer reserves the rights to change and update the rules and terms & conditions and have the final decision on any dispute.
