In recent years, the number of HK-China cross-border divorce applications has been increasing. The laws and procedures dealing with family matters differ enormously between two places. This webinar provides a comprehensive overview of the current provision of laws and development in the areas of ancillary relief and assets distribution which involves PRC properties. It involves sharing of experience in cases encountered in pursuing claims with the assistance of legal practitioners' effort and network in the PRC, and how discovery process is crucial in claiming assets that have been transferred to a third party pursuant to application under section 17 of the Matrimonial Proceedings and Property Ordinance.

In addition to the introduction of fundamental principles and concepts in the matrimonial law regime, this webinar will also offer some insights to the reciprocal recognition and enforcement of matrimonial judgments between Hong Kong and the Mainland.
