Proposed Standard for Audits of Less Complex Entities

This webinar will provide an overview of the International Audit & Assurance Board's (IAASB) Proposed International Standard on Auditing for Audits of Financial Statements of Less Complex Entities (ISA for LCE).

There has been growing concern about the length, scalability, and understandability of the International Standards on Auditing (ISAs), and their application to audits of Less Complex Entities (LCEs), including whether they can be applied in a cost-effective manner to all audits.

In response to these concerns, the IAASB has developed a draft stand-alone standard intended to provide reasonable assurance in an audit of the financial statements of an LCE. The IAASB considers the new stand-alone standard:

- is designed specifically for audits of a less complex entities
- is based on the underlying concepts from International Standards on Auditing
- was developed to be understandable, clear and concise
- reduces the risk of jurisdictional divergence by driving consistency and comparability globally
- will achieve a quality audit engagement

A Q&A session will be included during the webinar providing opportunities for participants to explore the proposed ISA for LCE and ask questions.
