# **Briefing session on FRC Interim Inspection Report** and Annual Investigation Report

#### **COURSE HIGHLIGHTS:**

The Financial Reporting Council (FRC) has published its Interim Inspection Report and Annual Investigation and Compliance Report in November 2021. The reports provide intelligence to auditors, investors, preparers and audit committees on common examples of non-compliance in listed entity financial statements, misconduct of their auditors as well as information on inspection findings in the middle of the FRC's 2021 inspection cycle.

The webinar will highlight the major findings that the FRC has identified and the FRC's recommendations on how audit quality and the quality of financial reporting can be improved. Participants can take home with them recommendations on taking actions to avoid recurrence of common accounting non-compliance and auditing irregularities or misconduct.

This live webinar is a platform for interactive-learning. The Q&A session at the end of the webinar provides a good opportunity for participants to explore the topics in more detail and ask questions.
