The Stock Exchange of Hong Kong Limited <u>published</u> the conclusions to its consultation on Review of the Corporate Governance Code and Related Listing Rules at the end of last year. Among the changes, listed companies need to align their culture with their purpose, values and strategy. A <u>Corporate Governance Guide for Boards and Directors</u> has been subsequently published to illustrate the expected disclosures under this initiative; as an example, listed companies should disclose the measures used for assessing and monitoring culture (e.g. specific indicators, such as staff turnover rate, whistleblowing data, employee surveys, breaches of code of conduct, and regulatory breaches). To help companies understand how to navigate and govern corporate culture following these changes, the speaker of this webinar will cover:
