## Best Corporate Governance and ESG Awards series: The latest developments of CG and ESG

### About the topic

To enhance Hong Kong's competitiveness as a global financial centre, and to keep pace with the international developments, amongst others, the Stock Exchange of Hong Kong Limited has updated the corporate governance requirements under Appendix 14 (Corporate Governance Code), including integrating culture into the listed issuers' purpose, values and strategy, as well as incorporating additional disclosures on why long-serving INEDs, who have already served the board for more than nine years, should still be considered independent and should be re-elected.

On top of this, since Appendix 27 (Environmental, Social and Governance Reporting Guide) was last updated in late 2019, there have been a number of significant developments. Among them, the International Sustainability Standards Board (ISSB) published two exposure drafts earlier this year, setting out proposed International Financial Reporting Standards (IFRS) Sustainability Disclosure Standards, which may have far-reaching impacts on the local ESG requirements in due course.

Against this background, our speakers will cover key updates of CG and ESG, and how listed companies can get ready for these changes.
