

Live webinar: New Reporting Requirements for licensed insurance broker companies under the Insurance (Financial and Other Requirements for Licensed Insurance Broker Companies) Rules

COURSE HIGHLIGHTS:

The Insurance (Financial and Other Requirements for Licensed Insurance Broker Companies) Rules ("Rules") took effect on 23 September 2019. The Rules set out the requirements applicable to licensed insurance broker companies for minimum share capital, net assets, professional indemnity insurance, the keeping of proper books and records, and contents for audited financial statements and auditor's report.

In this seminar, speaker from the Insurance Authority will highlight requirements of the Rules, especially the new requirements (compared to the requirements under the previous self-regulatory regime) which are being phased-in for "specified insurance broker companies" over a period of years until 1 January 2024 in accordance with the Savings and Transitional Arrangements in the Rules ("Transitional Arrangements"), and share regulatory experiences and observations on the reporting by auditors under the Rules. There will be a Q&A session at the end of the seminar to address participants' questions or comments.

This live webinar encourages interactive-learning. A Q&A session will be included during the webinar providing opportunities for participants to explore the topics in more detail and ask questions.
