Format:	<ul style="list-style-type: none">• Four games for each contestant.• No handicap will be considered in scoring.• There will be 3 grades, namely A, B and C. The average score of the 4 games played will determine which “grade” a contestant will be competing in. The highest scorer of each grade will be the champion.• Click here for the grading rules.
Equipment:	<ul style="list-style-type: none">• Shoes rental is available at \$15 per pair at SCAA.• Contestant can bring their own bowling equipment if they wish.
Prizes:	<ul style="list-style-type: none">• Champion, 1st Runner-Up and 2nd Runner-Up for each grade.• Awards for "Overall Single Highest Scoring Game" for men and women. (Prize presentation will be held immediately after the competition.)
Remarks:	Contestant's results will be used as reference for the selection of representative team members for future external competitions including the Recreation and Sports Club for HK Professional Bodies Tournament.
