# Bridge Tournament 2023 – Team Event

## About the tournament

1. The tournament is a team event.
2. Only HKICPA members are eligible to join this tournament.
3. Each team can consist of 4 to 6 players. For teams with more than 4 players, the team captain will decide on the line up of each round as he/she deems fit subject to any direction as may be given by the tournament director.
4. This tournament serves as a selection process for the upcoming RSCP Bridge Tournament (the date is yet to be confirmed), therefore the winning team will be invited to represent the Institute. However, the Institute and the Sports and Recreation Committee Chairman reserve the right to decide on the composition of the final team members of the Institute's team as deemed necessary when unforeseen circumstances arise. \*

(\*Any teams representing the Institute in external competitions are subject to endorsement by the Sports and Recreation Committee Chairman.)

## No show penalty

As it is a team event, any registered player who does not show up at the tournament will jeopardize his/her team to take part in the tournament. To ensure smooth operation of the tournament, the Institute will, at its discretion, impose a penalty to the defaulter in the form of barring him/her from entering into the next CPA Bridge Tournament or Mini Bridge Tournament, unless a replacement is found in time to enable the tournament to proceed without disruption.

## Awards

Medals will be awarded to champion, 1st runner-up and 2nd runner-up team.

### **Terms for Enrolment in Sports IG Activities**

Any enrolment in the activity is based on the participant's assessment that she/he is fit to participate and the assumption of all the risks and hazards inherent in the said activity. The participant agrees not to hold HKICPA or the convenor of the interest group liable for any loss or damage that the participant may suffer as a result of the participation.

The participant further agrees to follow the instructions from trainers (if any) or the tournament director and observe the [Event Participation Guidance](#). Any failure to follow such instructions will result in the participant's exclusion from the activity. The convenor of the interest group or trainer (if any) or the tournament director may determine, in the interests of safety or other considerations, whether an activity shall continue or whether a particular participant is allowed to continue to participate.

### **Notes:**

1. Priority for enrollment will first be offered to BrIG members and then to non-BrIG HKICPA members in the case of over subscription.
2. This event is subject to cancellation should the minimum number is not reached.
3. Full payment must be made before your enrolment will be processed. No telephone reservation will be accepted.
4. The Institute has the discretion to accept late enrolments after the closing deadline as it sees fit on the condition that a team of at least 4 members can be arranged for the tournament. Otherwise, the Institute has the discretion to reject the late application.
5. Unless the activity is cancelled due to unforeseen circumstances, low enrollment or bad weather, no refund for withdrawal will be entertained after the enrollment has been processed.
6. Bad weather arrangement: The activity will be cancelled if typhoon signal no. 8 or above / Black Rainstorm Warning is hoisted two hours prior to the commencement of the activity.
7. The Institute reserves the right to change the venue and date of the tournament due to unforeseen circumstances.
