2. Registration is on a first-come first-served basis. Priority for enrollment will first be offered to DIG members and then to non-DIG HKICPA members in the case of over subscription.
3. Full payment must be made directly to the Convenor upon confirmation of your enrolment.
4. The Convenor has the discretion to accept late enrolments after the closing deadline as it sees fit.
5. Unless the activity is cancelled due to unforeseen circumstances, low enrollment or bad weather, no refund for withdrawal will be entertained after the enrollment has been processed.
