ABOUT THE PORGRAMME

In 2005, the Institute developed and issued the Small and Medium-sized Entity Financial Reporting Framework and Financial Reporting Standard (SME-FRF & SME-FRS). It was designed to be straightforward for entities with simple businesses or transactions to apply. Hence, it is a predominantly cost-based standard. Between 2012 and 2019, amendments to the Hong Kong Companies Ordinance Cap. 622 (CO) led to revisions of the SME-FRF & SME-FRS. The most recent amendments to the CO issued in February 2019 expanded the eligibility to apply the SME-FRF & SME-FRS, among other things, and now entitles groups comprising a mix of small private companies or eligible private companies and small guarantee companies and groups that include non-Hong Kong body corporates to use the simplified standard.

This e-seminar will give an overview of the SME-FRF & SME-FRS, cover which entities are eligible to use it and go through the transitional requirements in the first year of adoption.

This e-seminar is recommended for practitioners/preparers who want to understand or know more about the SME-FRF & SME-FRS. We also encourage anyone who would benefit from a refresher on the SME-FRF & SME-FRS and its eligibility requirements to take the course
