Briefing on New Capital Investment Entrant Scheme

HIGHLIGHTS

The New Capital Investment Entrant Scheme ("the Scheme") was launched on 1 March 2024 which aims to attract asset owners to settle in Hong Kong and explore its diverse investment opportunities through wealth allocation and management. The New Capital Investment Entrant Scheme Office ("New CIES Office") under Invest Hong Kong is responsible for assessing the financial assets and investment of the Scheme Applicants as well as monitoring their continuous compliance of the Investment Requirements and Portfolio Maintenance Requirements, while Immigration Department is responsible for assessing applications for visa/entry permit, extension of stay and unconditional stay pursuant to the Scheme.

The Scheme Applicant is required to engage a Certified Public Accountant (Practicing) as defined in the Accounting and Financial Reporting Council Ordinance (Cap. 588) at his/her own cost to issue Fulfillment documents in demonstrating his/her fulfillment of the Net Asset Requirement, Investment Requirements and Portfolio Maintenance Requirements.

- Guide on preparation of Fulfillment documents in demonstrating the applicant's fulfilment of Net Asset Requirement and Investment Requirements
