- Assembly time and place: **10:00 am at the registration counter in Section A area**
- Fee: **\$260 (inclusive of 4 games)**
- Eligible player: HKICPA members only
- Capacity: Min 16 (max 20)
- Format:
- Four games for each contestant.
 - No handicap will be considered in scoring.
 - There will be 3 grades, namely A, B and C. The average score of the 4 games played will determine which “grade” a contestant will be competing in. The highest scorer of each grade will be the champion.

 - Contestant can bring their own bowling equipment if they wish.
- Prizes:
- Champion, 1st Runner-Up and 2nd Runner-Up for **each grade**.

- Remarks: Contestant's results will be used as reference for the selection of representative team members for future external competitions including the Recreation and Sports Club for HK Professional Bodies Tournament.

4. Successful registrants will receive confirmation by email or by telephone, whereas unsuccessful registrants will receive full refund.
