Event organiser will collect the receipts and arrange reimbursement via FPS (轉數快)

after the event.

<a href="Participation Guidance">Participation Guidance</a>. Any failure to follow such instructions will result in the participant's exclusion from the activity. The convenor of the interest group or trainer (if any) may determine, in the interests of safety or other considerations, whether an activity shall continue or whether a particular participant is allowed to continue to participate.

### Notes:

- 1. This activity is arranged by Sailing Interest Group (SIG), Event organiser Alex Yuen will contact you for event details and payment method.
- Registration is on a first-come first-served basis. Priority for enrolment will first be offered to SIG interest group members and then to non-SIG interest group HKICPA members in the case of over subscription.
- 3. Participants are required to reserve the dinghy or windsurfing board via LCSD and pay the rental fee in advance. Event organizer will collect receipts on-site and arrange reimbursement to participant.
- 4. SIG has the discretion to accept late enrolments after the closing deadline as it sees fit.
- 5. Unless the activity is cancelled due to unforeseen circumstances, low enrolment or bad weather, no refund for withdrawal will be entertained after the enrolment has been processed.
- 6. Bad weather arrangement: The activity will be cancelled if typhoon signal no. 8 or above / Black Rainstorm Warning is hoisted 2 hours prior to the commencement of the course.
- 7. The event organiser reserves the right to change the venue and date of the activity due to unforeseen circumstances.
